NOTICE 2024**

**NOTICE** is hereby given by the Council of the City and County of Swansea in pursuance of its powers as contained in section 14 (2) of the Road Traffic Regulation Act 1984 (as amended) that from Monday 8<sup>th</sup> April 2024 for a period of 21 days only (or until the works are completed whichever is sooner – it is anticipated that the work will take 3 days to complete), no person shall cause any vehicle to be driven as referred to in the schedule below. In order for Morrisons Water Services on behalf of Dwr Cymru Welsh Water to carry out works to repair a leaking water valve at the above location, it will be necessary to temporarily close the above road in part to vehicular traffic.

**SCHEDULE - TEMPORARY EMERGENCY ROAD CLOSURE  
GELLIONEN ROAD, SWANSEA**

Gellionen Road from its Junction with Llwyn On in a southerly direction to its junction with access lane to Gellionnen-Isaf Farm, a distance of approximately 150 metres.

The alternative route for vehicular traffic will be via Llwyn On, Tan Y Coed Road and the unaffected length of Gellionen Road A distance of approximately 500 metres.

Similarly this route will operate in the reverse direction and is suitable for light vehicles only.

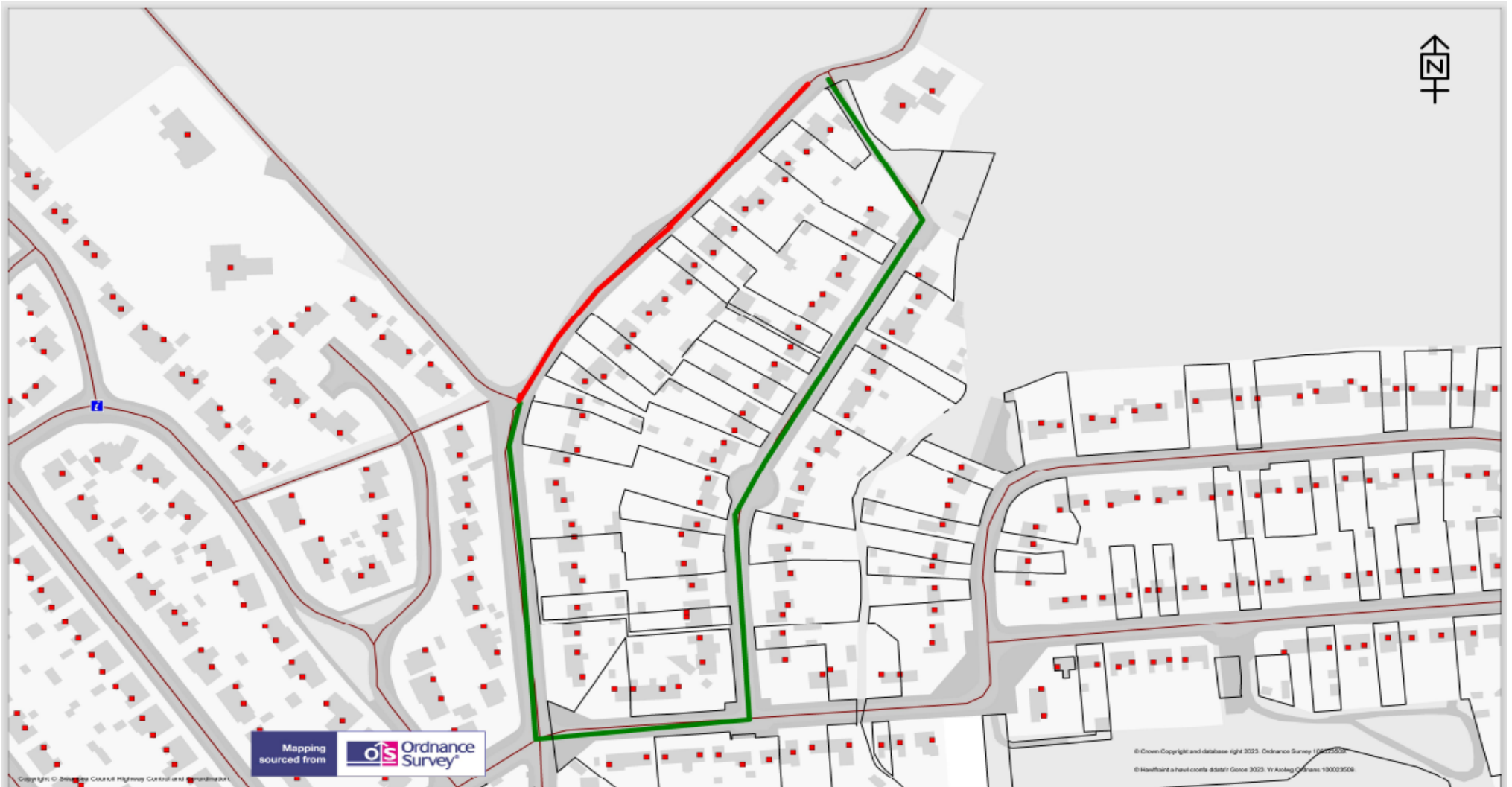
**Access for emergency vehicles and pedestrians to be maintained at all times.**


The applicant will be responsible for the erection and maintenance of all advanced warning, Road Closed, diversion and alternative route signs in accordance with Chapter 8 of the Traffic Signs Manual and the Traffic Signs and Regulations and General Directions 2016 for the duration of the works.
